Motion by Minkel to accept the Planning Commission's recommendation from the November Public Hearing to eliminate section 20.10 item letter D in the zoning book. Second by Withey. Motion carried.

Motion by Herzog to get two debit cards for the fire department with Rick Rockafellow and Josh Herzog being the cardholders. Second by Withey. Motion carried.

Motion by Herzog to get a debit card for maintenance expenses with Andy Reynolds being the cardholder. Second by Withey. Motion carried.

Motion by Herzog to pay the monthly bills. Second by Withey. Motion carried.

Public comment was given.
