Approval of the October 11, 2023, minutes from the regular meeting of the Board, motion by Forrest Herzog, Treasurer, second by Andy Reynolds, Trustee. Motion carried.

Motion by Forrest Herzog, Treasurer, second by Andy Reynolds, Trustee to approve agenda, motion carried.

Department Reports:

Treasurer's report, Forrest Herzog reviewed account balances.

Motion by Tarin Minkel, Trustee, to pay monthly expenses, second by Andy Reynolds, Trustee. Motion carried. Total monthly expenses approved: \$64,555.19.

Fire department report – Chief Joshua Herzog; monthly activity one smoke investigation, 2 gas leaks, and 1 vehicle accident.

Received a state grant in the amount of \$10,000.00.

Motion by Forrest Herzog to set a spending limit of \$5,000.00 (five thousand), for the fire department, second by Andy Reynolds, motion carried.

Motion by Tarin Minkel, Trustee, to allow the fire department to purchase turn-out gear, outside lighting, removal of the sign, wiring for compressor, and gear driers. Purchase total in the amount of \$41,706.85, second by Andy Reynolds, Trustee. Motion carried.

Zoning report- Dave Kelsey, Zoning Administrator, had six permit requests and two land splits.

Cemetery report- Chris Reynolds, Cemetery Manager discussed the Chapel cleaning estimates for spring cleaning, one cremation burial, and the removal of the military flags. Flags in the chapel and **township** hall are unable to be cleaned. Yolanda Lane, Clerk will be looking into prices for replacing the flags and of disposal of current flags.

Campground report – No report due to the campground being closed for the season.

Planning Commission – Tarin Minkel, Trustee reported the Solar ordinance was completed and sent to the county. Working on amending ordinances: privacy fence, and additional small items for example, pools. Working on short-term rentals ordinance, Leslie, Attorney has provided feedback. Tarin Minkel, Trustee will review and customize documentation provided by Leslie.

New Business:

The county would like the Board to adopt the Hazard Mitigation Plan. Tarin Minkel, Trustee, asked for a presentation from the county at our next meeting. Armon Withey, Supervisor, will reach out to them and organize the presentation.

Ken Purchase commented that the Wind and Solar Bills in the state legislature that were recently passed will not take effect until one year after the governor signs them, due to not passing by super majority.

Motion by Tarin Minkel, Trustee, to amend Section C general standards, Part 1 adding "NO LARGE" to sentence and (Farmland and Open Space Preservation Program) to the end, second by Andy Reynolds, Trustee. Motion carried.

Motion by Tarin Minkel, Trustee, to amend Section C general standards, Part 6 to read the maximum lot coverage ratio for Medium and Large SES, including the solar panel layout, shall be no greater than 40% of the given parcel. Large SES shall not be constructed on parcels less than forty (40) acres. The minimum required may consist of multiple contiguous parcels totaling 40 or more acres., second by Andy Reynolds, Trustee. Motion carried.

Motion by Tarin Minkel, Trustee, to amend Section C general standards, Part 10 by adding an item vi to subpart b to read Any tree that dies shall be replaced within one year by following the same criteria for size and spacing and removing subpart d, second by Andy Reynolds, Trustee. Motion carried.

Motion by Tarin Minkel, Trustee, to correct spelling and grammar errors in the document, second by Yolanda Lane, Clerk. Motion carried.

Motion by Tarin Minkel, Trustee, to add Section 2.6, Performance Guarantee, from the Zoning Ordinance to the solar section for reference, second by Andy Reynolds, Treasurer. Motion carried.

Motion by Tarin Minkel, Trustee, to amend Section F, Part 14 to add and shall be in the geographic center of the site. The approving body may permit the location of the inverter be moved but no closer to a non-participating property., second by Andy Reynolds, Trustee. Motion carried.

Motion by Tarin Minkel, Trustee, to change Section C, Part 16 to read the applicant shall submit proof of liability insurance in the amount of \$25,000,000 per occurrence with Belvidere Township listed as additionally insured. Second by Andy Reynolds, Trustee. Motion carried.

Motion by Tarin Minkel, Trustee, to add for approval by the Montcalm County Road Commission, Michigan Department of Transportation and the Township Board. To Section F, Part 8, second by Andy Reynolds, Trustee. Motion carried.

Motion by Tarin Minkel, Trustee, to add, third party engineer agreed upon by the Township to Section C, Part 18 and Section F, Part 13, second by Andy Reynolds, Trustee. Motion carried.

Motion by Tarin Minkel, Trustee, to accept changes to zoning ordinance # 18 to define and authorize solar energy systems, to establish approval procedures and standards for solar energy systems, second by Andy Reynolds, Trustee. Motion carried.
